

Area Agencies on Aging - Agencies around the state that provide case management, information, and referrals to services for people who are aging or developmentally disabled.

**AssessmentPro** - The web-based system that is used in Indiana LCAR to complete NFLOC and PASRR assessments and determinations.

Authorized Representative - A person who has been specifically authorized by an applicant or recipient of health services or other benefits to receive that person's private health information or other confidential information and, if expressly authorized, to act on behalf of the beneficiary or applicant.

**Dual Diagnosis -** Mental Illness and Intellectual Disability/Related Condition

Enrollment Broker - An entity that helps people enroll in Medicaid health plans and provides counseling on health plan selection.

HCBS Waiver - An HCBS waiver is a Medicaid program that allows people to receive long-term care services in their home or community instead of an institution. HCBS waivers are also known as Section 1915 waivers.

Health Plan - A health plan is a healthcare insurance company. Indiana partners with health plans for its Indiana PathWays for Aging, Hoosier Healthwise, Healthy Indiana Plan, and Hoosier Care Connect programs.

Health and Wellness Waiver (H&W) Waiver - A Home and Community-Based Waiver program in Indiana for people who are under age 60, Medicaid eligible, and meet nursing facility level of care.

Home and Community-Based Services (HCBS) - These are services for eligible people who choose to remain in their home as an alternative to residing in a long-term care institution (such as a nursing facility).

Indiana Health Coverage Program - Indiana's Medicaid Program. Indiana Medicaid provides services to over 1 million Indiana residents who are aged, disabled, blind, pregnant, or meet other eligibility requirements.

Intake Counseling - Intake counseling is an interactive process where individuals receive information about the available HCBS and LTSS services that the State officers to support the individual in making a decision about their preferred option.

interRAI EY - An assessment used to evaluate the needs of young children with health care challenges who are seeking or receiving long-term supports and services. It is the assessment used in Indiana for young children under age 4 to determine if they meet NFLOC.



interRAI HC - An assessment used to evaluate the needs, strengths, and preferences of people in home and community care settings that can used to assess people with chronic needs for care as well as people with postacute care needs. It is the assessment used in Indiana for adults to determine if they meet NFLOC.

interRAI PEDS-HC - An assessment used to evaluate the needs of children with health care challenges who are seeking or receiving long-term supports and services. It is the assessment used in Indiana for children aged 4-18 to determine if they meet NFLOC.

**Legal Guardian** - The person or entity who is court appointed and legally responsible for decision-making on behalf of an individual to determine if they meet NFLOC.

Managed Care - An arrangement whereby a single provider or organization oversees the overall care of an individual so as to support costefficient quality health care to its members.

Managed Care Entity (MCE) - The entities in Indiana that provide Medicaid health plans for individuals that are in a population that receives managed care.

## Money Follow the Person (MFP) -

MFP is a program funded through a grant from CMS that helps individuals move from an institutional setting like a NF back into their community while still receiving needed services and supports.

**Nursing Facility Level of Care** 

(NFLOC) - A Nursing Facility Level of Care is a measure of the level of care a person needs to be eligible for Medicaid funded nursing home care. The same criteria is also used to determine eligibility for certain HCBS Waivers. Determining NFLOC involves an assessment to determine a person's needs, typically around their ADLs, medical conditions and medical needs, cognitive functioning, and behavioral needs.

PASRR - PASRR is a federal program that helps make sure people with SMI, ID/DD, or RC are not inappropriately admitted to nursing homes for long term care and also helps identify the services they need if they do admit to a nursing facility.

PASRR Level I - PASRR screening tool for persons admitting to Medicaid certified NFs, who have or may have a known or suspected Serious Mental Illness (SMI), intellectual/Developmental Disability (ID/DD), or Related Condition (RC).

PASRR Level II - In-depth PASRR evaluations for persons with a known or suspected Serious Mental Illness (SMI), Intellectual/Developmental Disability (ID/DD), or Related Condition (RC).



**PathWays for Aging -** PathWays for Aging is a managed care program for Indiana Medicaid members who are 60 years of age or older

PathWays for Aging Waiver - An HCBS Waiver program in Indiana for people who are aged 60 and up, Medicaid eligible, and meet nursing facility level of care.

**Provider** - Health care provider or agency providing medical care or services

Program of All-Inclusive Care for the Elderly (PACE) - PACE is a program for people age 55 or older who meet NFLOC. PACE organizations are managed care entities (MCEs) who serve as the sole service provider for all services the individual needs, including primary care, hospital care, emergency home care, nursing home care, and other services and supports.

**Specialized Services** - Intensive services exceeding those which can be provided by NF staff or rehabilitative services

**TBI Waiver** - An HCBS Waiver program in Indiana for people who have a traumatic brain injury, are Medicaid eligible, and meet nursing facility level of care or IDC/IID level of care.
